PRESIDENT'S REPORT

Liasions from the BOD also have been appointed: Randy Bomer is the BOD liaison to the Ethics Committee ICG, Ray Reutzel is the BOD liaison to the Doctoral Student ICG, and Diane Schallert is the BOD liaison to the Gender and Sexualities ICG.

Fourth, we welcome the new LRA Yearbook editorial team from the University of Missouri: Elizabeth (Betsy) Baker, Jennifer Clifton, Carol Gilles, Laurie Kingsley, Candace Kuby, Amy Lannin, Lenny Sanchez, and Angie Zapata. We also are pleased to share with you that the Journal of Literacy Research editorial team (Patty Anders, David Ayden, Chris Iddings, Laurie Katz, and Theresa Rogers) has requested, and received BOD approval, for an additional year of journal editorship. A special thank you to Jackie Malloy, Clemson University, for her exceptional service to the organization and leadership as editor of the bi-annual LRA Newsletter.

Fifth, we offer a very special note of gratitude to Diane Tracey, Kean University, who has served as LRA Secretary for several years. We

will miss Diane's thoughtful comments and suggestions as well as her institutional memory. A new Secretary has been named: Lynn Shanahan, University at Buffalo - SUNY. Chair of LRA Field Council Jennifer Jones, Radford University, is also stepping down from her position. We are grateful to Jennifer for her outstanding service to the organization. We will miss her enthusiasm and positive influence. We welcome Grace Enriquez, Columbia University, Teachers College, who has agreed to serve as Chair of Field Council.

Sixth, LRA Committee Chairs and members have been very active this year. Below, please read their reports in this Newsletter. There are two committees whose work deserves special mention. The Publication's Committee Chair, Thomas (DeVere) Wolsey, initiated and completed an EBSCO (online index for multiple research databases) licensing agreement for LRA. Our partnership with EBSCO does not incur any costs for LRA. DeVere, working with Dixie Massey, has retrieved issues from 1957 forward, with a small gap, so that the LRA Yearbook will be accessible online. In addition, the LRA Technology Committee, headed by Erica Boling, working with e-Editors Greg McVerry and Ian O'Byrne, Past President Richard Beach, and Wyn Bryant of KWMG, has made significant progress on redesigning and updating the LRA website. The launch of our new website will occur this fall.

Seventh, we are pleased to announce the inaugural Sara B. McCraw Literacy Fund. Although I did not personally know Sara, I am aware of her involvement in LRA and her influence among doctoral students. For example, annually the Doctoral Student ICG commemorates her import to LRA with a designated event, the Sara Bruce McCraw Doctoral Student Networking session. An excerpt from the foundation's home page (http://www.whensarasmiles.com/) is below:

Dr. Sara B. McCraw was an Assistant Professor at East Carolina University. Before that, she earned a B.S. in Psychology from James Madison University, a B.S in Early Childhood Education from the University of Maryland, a Reading Specialist Certification (M.Ed.) from the University of Delaware, an M.A. in Education from the University of Delaware, and finally, a Ph.D. in Education from the University of Delaware. She had just begun her career at ECU in 2011 and was well on her way to building a national reputation in the field of writing research when she lost her battle with cancer in 2012. Sara was an active member of the graduate student community with LRA since beginning her doctoral work at the University of Delaware.

The \$500.00 grants are available to eligible graduate students to help offset travel to the LRA annual conference. Information and application forms for the grant are available on the LRA website.

Finally, we are very excited about the incredible response to the 64th LRA Conference call for proposals. Currently there are limited rooms available at the Marriott, however, we have made similar

accommodations for additional guests at the Hilton. Co-Chairs Janice Almasi and Patricia Enciso have arranged an engaging program, impressive plenary speakers, and timely theoretical challenges, as well as retained several traditional LRA events. We are looking forward to an outstanding and memorable conference at the Marriott Marco Island.

PRESIDENT-ELECT'S REPORT

The theme of the 64th Annual Conference is "The Dialogic Construction of Literacies." The conference will be held December 3-6, 2014, at the Marco Island Marriott, which is situated on 3.5 miles of beachfront property along the Gulf of Mexico. In addition to the beaches that are steps from the hotel and meeting rooms, the Marriott features two swimming pools, a Balinese-style Spa and Fitness Center, golf, tennis, beach volleyball, and basketball. The Marco Island Marriott has just completed a renovation and redesign of the entire property including all guest rooms and meeting room spaces. The property boasts eight restaurants (including Quinn's, a beachside bistro that will drive your lunch to you on the beach). As well, there are 75 other restaurants on the island within walking distance or a very short cab ride away.

Marco Island is close to Ft. Myers and Naples and is accessible by flying into Southwest Florida International Airport (RSW), which offers nonstop service to 45 domestic and international destinations. Registration for the conference, hotel accommodations, and ground transportation are available on the LRA website at http://www.literacyresearchassociation.org/.

This year we received a record number of proposal submissions (n = 1021), which meant that over 3,000 reviews were completed. I would like to extend my most sincere appreciation to all of the Area Chairs who selected qualified reviewers for their areas, screened proposal submissions for appropriate formatting/word count, assigned proposals for review to qualified reviewers, made recommendations to me based on the reviews, and created grouped paper sessions. Their contributions were critical to creating the program, and I am grateful for their assistance and expertise. As well, I would like to thank everyone who volunteered for, and completed, the many reviews.

Our plenary addresses this year include:

- Arlette Willis, President of LRA, who will deliver the Presidential Address on Wednesday, December 3, 2014, from 4:45 - 6:00 PM. The President's Reception will follow immediately after the address, to which all attendees are invited.
- Yetta Goodman will deliver the Oscar Causey Address on Thursday, December 4, 2014, from 10:30 AM - 12:00 PM. Her address is entitled, "Miscue Analysis: A Transformative Tool for Researchers, Teachers and Readers."
- Rupert Wegerif, Professor of Education at the University of Exeter will deliver the plenary address on Thursday, December 4, 2014, from 4:45 - 6:00 PM. His research focuses on teaching thinking through dialogic education with technology. His recent work includes the book, *Dialogic: Education for the Internet Age*.

- George Lakoff, Richard and Rhoda Goldman Distinguished Professor of Cognitive Science and Linguistics at the University of California at Berkeley, will deliver the plenary address on Friday, December 5, 2014, from 4:45 - 6:00 PM. Lakoff, an expert in the field, will speak on, "Why the Brain Changes Everything: What Embodied Cognition Tells Us about Literacy."
- The Integrative Research Review on Saturday, December 6, 2014, from 10:30 am 12:00 PM will be "A Conversation about the Contributions of Content Knowledge and Strategic Processing to Reading Comprehension." Annemarie Palincsar, University of Michigan, will moderate the session. Panelists will include: Maren Aukerman, Stanford University; Rachel Brown, Syracuse University; Kouider Mokhtari, University of Texas at Tyler; and Sheila Valencia, University of Washington.

The Distinguished Scholar Lifetime Achievement Award session will feature this year's recipients, Marilyn Cochran-Smith, Boston College, and Susan Lytle, University of Pennsylvania. Their presentation, "The Uncertain Terrain of Practitioner Research: A Conversation" will be on Friday, December 5, 2014, from 10:30 AM - 12:00 PM.

I am also pleased to announce the revitalization of Vital Issues, which the Field Council will take the lead in organizing. Vital Issues is a time to continue discussions about vital issues in literacy research and meet old and new friends in an informal setting. It will be held from 9:00 PM onward in the lobby bar each evening. All members are invited to attend and continue conversations about each day's events.

If you are new to LRA or the conference, I offer the following tips to assist in planning your conference experience:

- (1) Attend all plenary sessions. The plenaries are the common text of the conference that brings out the theme. The plenary sessions are held each afternoon (W,Th,F) from 4:45 6:00 PM. In addition, the Oscar Causey Address is always on Thursday morning (10:30 AM 12 PM). The final plenary, the Integrative Research Review, occurs on Saturday morning (10:45 AM 12:00 PM).
- (2) Attend the Presidential Reception immediately after the Presidential Address. This year the reception will be held on the Sunset Terrace immediately following the Presidential Address on Wednesday, December 3, 2014.
- (3) Attend the events organized by the Field Council including the Newcomers/Graduate Student breakfast on Thursday, December 4, 2014, from 7:30 8:30 AM. This event offers graduate students, and those who are new to the conference, the opportunity to meet the leadership of the organization and learn more about the organization. The breakfast is complimentary to newcomers and graduate students as long as you sign up in advance.
- (4) Attend the Town Hall Meeting on Thursday evening immediately following the plenary. This is where issues of concern to the organization are brought forward and discussed publicly. It is an opportunity for the leadership to listen to the membership. Although social media and technology enable us to have this opportunity throughout the year, the Town Hall represents a lively face-to-face exchange of ideas (and an opportunity to meet other scholars).

(5) Attend the Business Meeting on Friday immediately following the plenary session. This event offers an opportunity to learn about the mechanics of the organization (i.e., finance, governance, future conference sites, election slates, transfer of leadership).

The nominees are people who represent the qualities of leadership, commitment to diversity, and scholarship that help LRA grow and continue to be recognized as a leading community of researchers, educators, and policy-shapers. 2016 Conference Site Visits

Vice President-Elect Rebecca Rogers and I set off on a journey to several states to identify sites for the 2016 Conference. Many, many decisions have to fall into place to make a site work for LRA. To begin with, we need a ballroom that will hold at least 900 people. Only a few hotels in any city have that capacity. We also need an excellent room rate, good Internet access, nearby restaurants, and 'grab and go' food with good prices. Most of all, we need good 'flow' so attendees can meet up with one another in between sessions or gather spontaneously

before and after a keynote address. This means we tend to look only at hotels or resorts and not at convention centers. The search takes many hours of focused attention, travel, and ongoing negotiations. We are grateful to Julie Dross, Lynn Hupp and the KWMG team who help make the site-finding process a success.

In addition to these duties, I am also trying to understand how LRA, as a whole organization, can best engage our expertise and resources (including time) to address the urgent and rapidly changing demands for understanding literacy education. What pathways of dialogue can we promote within our different areas of expertise (e.g., multilingual research) to open up and authorize interpretations of research for colleagues in local, state, and national settings? How does LRA best represent this expertise to a wider audience? What forms of action might different areas of research promote or suggest to a wider audience? What forums are best used for this kind of inquiry? Members of the LRA Policy and Legislative Committee have taken a leading role in formulating statements and working with national organizations so that our members have a voice in circles beyond LRA. This work is vital. At the same time, PLC is able to extend this work and support other LRA members (Area Chairs, ICGs) in identifying key concerns that might be set forth as statements for wider audiences. I invite Area Committee, ICG, and other committee members to consider what matters most as a response to current issues in your area of expertise. What can you say to a wider audience that is researchbased, and might be a beacon for colleagues and educators — maybe even policymakers — who are in the midst of making difficult decisions about literacy education.

PAST PRESIDENT'S REPORT

As I wrap up my four-year term of service to LRA, I would like to acknowledge the efforts of the other past and present officers who have helped me assume various responsibilities associated with serving on the Executive Committee.

I would also like to thank certain members for making some lasting contributions to LRA. Over these past four years, I have witnessed an increased, significant focus on diversity in ways that address the LRA mission statement that "the Literacy Research Association (LRA) is a community of scholars dedicated to promoting research that enriches the knowledge, understanding, and development of lifespan literacies in a *multicultural and multilingual world*" (italics mine).

This support for a focus on diversity stems from the work of groups within LRA: Ethnicity, Race, and Multilingualism (ERM), as led by Julia Lopez-Robertson and Marcelle Haddix, and their work with the STAR (Scholars of color Transitioning into Academic Research) program that has mentored scholars of color who are now assuming active roles in LRA; as well as the efforts of the Multilingual/Transcultural Literacies; International; and Gender and Sexualities ICGs. This increased focus on diversity has become essential to LRA's ability to support literacy research informing instruction for our increasingly more diverse student populations.

And, over these past four years, recognizing that a third of LRA members consist of doctoral students, I've been pleased with the vitality and growth of our Doctoral Student ICG, who, along with the Field Council, under the leadership of Jennifer Jones, have effectively socialized doctoral students into becoming active members of LRA.

I also applaud the work of the JLR editors, Patty Anders, David Yaden, Ana Christine de Silva Iddings, Laurie Katz, and Terry Rogers; and the work of our LRA Yearbook editors, Pamela Dunston and Susan Fullerton, for their editorial work that serve to enhance LRA's visibility within the research community, as well as the efforts of DeVere Wolsey and the Publications Committee to support these publications. [As someone who recommended the move to publish the Yearbook as an e-book, I appreciated the extensive work of the Publications Committee to examine and promote that effort]. And, thanks to Jackie Malloy for continuing her solid work over these many years as Editor of this Newsletter, as well as members of the Policy and Legislative Committee for their work on generating a number of Policy Briefs, an effort launched by Caitlin Dooley.

Further praise is due for the work of the Technology Committee led by Erica Boling. As indicated in her report, during this past summer, we engaged in a major revision of the LRA website to enhance its usability and access to resources for LRA members. For this website, we're retaining the Forums for use by Committees, Area Chairs, and ICGs to engage in their own, confidential discussions. We're adding the ability to tag content on the website so that members can search for relevant resources related to literacy research, resources that include the Research Repository that houses information about members' research interests. I urge members who have not done so to add their academic CVs tagged according to their particular research foci to that Research Repository.

I also want to thank Ian O'Byrne and Greg McVerry for their work producing the LRA Research to Practice webcast shows housed on the website, shows that addressing a number of issues of interest to LRA members.

And, I want to recognize the work of our new management firm, Kautter Wenhold Management Group (KWMG), for their first year of solid service supporting LRA. During this past summer, I chaired a committee consisting of Vice-President Pat Enciso and Board member Ray Reutzel, to conduct a performance review of KWMG. Our overall review was relatively positive, so we therefore look forward to working with KWMG in the future and our Executive Director, Lynn Hupp.

Finally, I want to thank all of the LRA members for assisting me in my various tasks over these past four years. DISTINGUISHED SCHOLAR LIFETIME ACHIEVEMENT AWARD

Marilyn Cochran-Smith is the Cawthorne Professor of Teacher Education for Urban Schools at Boston College's Lynch School of Education, where she directs the Doctoral Program in Curriculum and Instruction. Her extensive writings focus on teacher education research, policy and practice, and the role of practitioner research in initial teacher education both nationally and internationally.

Susan Lytle is Professor Emerita at the Graduate School of Education of the University of Pennsylvania. She directs the Reading, Writing, and Literacy Master's and Doctoral Programs and founded the 30-year old Philadelphia Writing Project as an urban school/university collaborative network.

Campus Rd, Lawrence, KS 66045). Also, please email the letter of nomination to Barbara Bradley (barbarab@ku.edu) so that she is aware that the book will be arriving in the mail. Self-nominations are accepted, although committee members cannot nominate a book they have authored. A book may be re-nominated if it has been previously nominated but did not win the award. J. MICHAEL PARKER AWARD CONTRIBUTIONS TO ADULT LITERACY

Dear LRA Colleagues:

If you are presenting a paper on the topic of adult literacy at the 2014 LRA conference, please consider applying for the J. Michael Parker Award. The deadline for submissions is October 1, 2014.

LRA awards the J. Michael Parker Award to new scholars—i.e., graduate students and those who completed their doctorates within the past six years—for a paper presented at the conference that address adult literacy/language development and instruction. The award was established in 2001 in honor of J. Michael Parker, winner of LRA's Student Outstanding Research Award for his work in community-based adult literacy.

Eligibility

To be true to the spirit of J. Michael Parker's work, the award recognizes studies that examine ways adults further their own language and literacy development within or outside of formal learning contexts, including different social and cultural contexts for learning. The award is designed to encourage work in adult literacy with a variety of populations, including, but not limited to, learners in formal settings such as adult basic education and ESOL classes, as well as those engaged in literacy practices embedded in diverse cultural settings.

Award Details

Recipients of the award receive a small cash award to be used for conference expenses, as well as a plaque commemorating the award. They are also recognized during a general session of the conference. The award is presented to both papers with a single author and to coauthored papers. For single authored papers, the recipient will receive

\$500 and a plaque commemorating the award. For co-authored papers, the recipients will each receive a plaque and will decide amongst themselves how to divide the \$500 award.

Criteria for Consideration for the Award

- The research is capable of making a significant contribution to theory and/or practice of adult literacy development and instruction.
- The methodology is appropriate to the research question and of sufficient rigor.
- 3. Implications of the research are of a scope needed to impact the field

Applicants are required to submit a full research paper (25 pages or less), based on the accepted proposal, by October 1,2014. Papers must be double-spaced and in 12-point font. The text limit does not include references or any appendices. Paper submissions and inquiries should be directed to the the award chair (Silvia Noguerón-Liu, snoguero@uga.edu). Potential applicants are welcome to consult with the chair about how their research may fit with the intentions of the award.

Our first awardee, Dr. Peter Johnston of S.U.N.Y. at Albany, received the award that was presented at our annual meeting in Dallas. This annual award honors, in P. David Pearson's name, the author(s) of an article/chapter/book written at least five years prior to the nomination, that has demonstrably and positively influenced/impacted literacy practices and/or policies within district, school and/or classroom settings.

We encourage you to think about influential materials that have affected your professional work and submit nominations by September 15, 2014, for consideration in 2014. Nominators should demonstrate how the findings or implications of the article/chapter/book have been used directly by educators to craft influential policies and/or initiate and implement innovative classroom practices.

The submission packet should include a letter of nomination outlining the case with supporting evidence (along with the key piece of writing, author's CV, and documentation of the influence of the piece on instruction and/or policy).

Announcing the 2014 Student Outstanding Research Award

Are you a graduate student who is already looking forward to next year's LRA Conference? Are you conceptualizing a promising paper based on your research? Consider applying for the LRA 2014 Student Outstanding Research Award. The Student Outstanding Research Award is awarded annually to honor a student member of LRA in recognition of an outstanding research paper presented at the Annual Conference.

Last year's award was presented to Angie Zapata, an Assistant Professor at the University of Missouri Columbia and alumni of the University of Texas, Austin who worked with Dr. Nancy Roser. Melody's award winning ethnography, "Examining the Multimodal and Multilingual Composition Resources of Young Latino Picturebook Makers" was selected from a competitive selection of submissions.

In order to be considered for the award, the author must hold student status and the research must be conducted by the student. The paper must be written solely by the student or co-authored with students, and cannot be co-authored or co-presented with a faculty member. The proposal must have been accepted by the Annual Conference Committee for presentation at the Annual Conference. Papers representing various forms and genres of research (including conceptual papers) are welcome.
